Scope:

- 31 high ranking, near-term mobility priority projects.
- Phase to be completed with 2010 Bond funds:
 - 11 preliminary engineering projects \$6.4M
 - 4 design projects \$4.9M
 - 2 ROW Acquisitions \$2.3M
 - 14 construction projects \$30.7M

Scope:

- New Advanced Traffic Management System

Traffic Calming/ Matching/ Quiet Zones Program Overview

Scope:

- To address speeding and cut-through traffic
- To help communities afford geometric street features
- To establish quiet zones at railroad intersections



Program Total	Amount Obligated	% Obligated
\$2,700,000	\$231,910 [\$827k]	9% [31%]

- Under Design & Construction
 - Traffic Calming: 40 devices in 5 neighborhoods
 - Matching: 6 devices in 2 neighborhoods
 - Quiet Zones: Signed 5 agreements with Union Pacific

Local Area Traffic Management (LATM) Program

Goals:

- Promptly address speeding and cut-through traffic in residential areas
- Use least restrictive measures to mitigate documented problems

Reason for new program:

- Narrowed the focus to individual streets, allowing the program to be more responsive to citizen issues
- Previous program took years to study and implement

Scope:

• The Travis County Partnership Program includes transportation facilities to improve connectivity and mobility within the city and the SH 130 corridor

- Tuscany Way South, US 290 East to Springdale Road Extension: \$1.5M
- Slaughter Lane, Goodnight Ranch Subdivision to Thaxton Road Extension: \$1.5M

- Austin to Manor Rail with Trail [\$1M] is in design and will not be obligated until fall 2012

Corridor Preservation Program Overview

Scope:

- Preemptive right of way (ROW) acquisition
- Acquisition of transportation corridors on private property
- Avoid costly future ROW condemnation

Program Total	Amount Obligated	% Obligated
\$1,000,000	\$55,000	6%

- Consultant is under contract to develop the assessment model and provide training for staff
- Staff continues to identify potential candidates for ROW acquisition as development occurs

Roadway Reconstruction Program Overview

Scope:

 Reconstruction of various streets, alleys, failing sections of curb & gutter and rehabilitation work on several bridges
