The EMS Department has now been able to secure a sufficient supply of Ketamine to provide adequate stocking for each unit and a supply inventory to support this medication. Attached are the affected Clinical Guidelines for Ketamine use. You may begin using this medication on the effective day of this Medical Directive <u>01 August 2017 @ 0700 hours</u>. Once Ketamine is implemented, all Guidelines and documents used by Special Operations for the Ketamine evaluation/trial become invalid and are no longer to be used for patient care.

A/TC EMS and the OMD have finalized the alternative patient transport programs (ATU, MCOT and direct transport to a Psychiatric Emergency Department). A single Clinical Guideline has been developed to establish a standardized set of criterion for referring patients under these programs.
